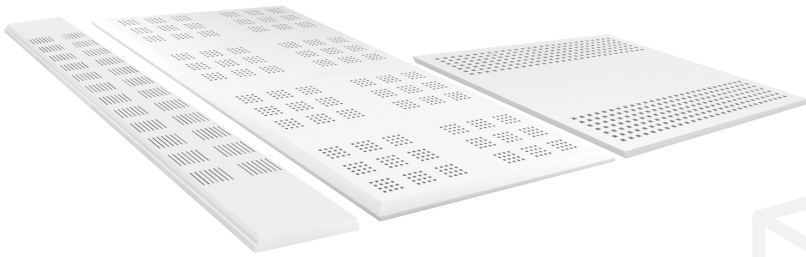

**Composition comments** Calcium sulfate dihydrate encased in paper liners. Natural constituents may include minor amounts of quartz.  
The tiles may be perforated or textured and the face decorated with paints and/or marble.  
Gyptone Line, Quattro, Sixto and Point have an acoustic tissue laminated to the back face.

### SECTION 4: First aid measures

#### 4.1. Description of first aid measures

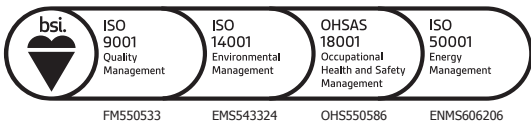
